# Beggar's Tunes Event Contract

This is an agreement between Beggar's Tunes Mobile DJ Service and

**Its purpose is to articulate the specific terms by which their business relationship shall exist.**

**Beggar's Tunes Responsibilities:** Beggar's Tunes will provide all lighting, sound and the music library appropriate to the specific engagement described below. They will provide a reliable high quality show free from major disruptive technical malfunctions of their equipment. As a host and MC, Beggar's Tunes will be responsible for delivering services outlined in the Event Planning Guide supplied to the Purchaser provided the guide is returned to Beggar's Tunes at least two weeks prior to the scheduled event. If no Event Planning Guide is used, Beggar's Tunes remains responsible for orchestrating contests, giving away prizes, making announcements on behalf of the Purchaser and any other host related duties necessary to make each event a special occasion for the Purchaser and their guests. Equipment setup to start ¾ to 1 hour prior to event start time (unless otherwise agreed upon). Equipment removal will commence immediately following event end time. If purchaser is dissatisfied with Beggar's Tunes' performance, they must submit a written explanation within 48 hours to obtain a full refund.

**Client Responsibilities:** The Purchaser listed above is responsible for supplying adequate power, and an area for the DJ equipment protected from the elements. Purchaser will also provide access to setup area 1 hour prior to event start time and 30 minutes following event end time unless otherwise agreed upon. In the event of circumstances deemed by Beggar's Tunes to present a threat or implied threat of injury to the DJ or any property (equipment, lighting, c.d.'s, etc.) in the DJ's possession, the DJ reserves the right to cease performance. Purchaser shall be responsible for payment in full, regardless of whether the situation is resolved or whether DJ resumes performance. It is understood and agreed that the Purchaser agrees to provide crowd control if warranted. Purchaser will be liable for any loss or damage to any property belonging to Beggar's Tunes that is caused by Purchaser or his/her guests, customers, students, etc. Balance of payment (minus 20% non-refundable reservation fee) is due at time of services. Events cancelled will be subject to a 20% cancellation fee (forfeiture of the reservation fee) unless date is rescheduled within 30 days of original date (subject to availability).
